Janet called the meeting to order at 10:05 a.m.
Secretary's Report Minutes from the meeting of June 10, 2016 had been previously approved via email. Valerie clarified that the actual pay pal transfer amount for her June report was $\$ 20,545.75$, a correction of less than \$1.

## 2. Membership Report

On behalf of Membership Chair, Ellyses, Heather reported that the MMTA has gained 7 new members since $7 / 1 / 16$ and Vivian indicated that welcome letters had been automatically generated. Heather reminded Vivian that some letters required updated for current calendar data. It was reported that 57 members have not yet remitted their annual membership fees, but that this is not unusual.

Dorothy inquired about outreach to new members and Karin agreed that some personal contact would result in a more active membership. Some technical matters as to how best to gather new member information for this communication was discussed. Proper handling of a request for a half-year membership was also discussed

## 3. MTNA State Competition Report

Caroline reported that she had experienced a rush of registrations just before the deadline of $9 / 14$, and that she was currently expecting 27 participants and 1 ensemble. She stated that the competition would require a woodwinds judge, which is a first for the MMTA. Registered entrants are as follows:

- 7 young artists: 6 saxophone, 1 violin
- 12 juniors: 6 piano, 5 strings, 1 clarinet
- 8 seniors: 5 piano, 2 string, 1 clarinet

The competition will be held at Brandeis University on November 6, 2016. This date is earlier than is customary and is based upon the availability of space at Brandeis.

A prolonged conversation ensued regarding competition judges. Alison and Dorothy stated that one highly qualified judge is sufficient, and that this is the standard held by other states. Vivian, Janet and others felt strongly that three judges would be preferable, although it was agreed that the expense, personality considerations and other logistics of multiple judges cannot be overlooked. Dorothy pointed out that based on MMTA standards, the difficulty is a result of the number of entrants we have this year, as they often fall very near the cut-off points for one or three required judges. Additional ideas and opinions were put forward.

Motion by Valerie, Second by Vivian: As a trial for this year's competition only, 3 judges will be hired for categories with 5 or 6 entrants and 1 judge will be hired for categories with 4 or fewer entrants. Discussion: Alice noted that since this strategy requires evaluation, monitors for the event will be especially important as observers and information gatherers regarding the
effectiveness of the policy. Vote: 10 approved, 2 opposed, 0 abstentions, Motion Passed

Leslie presented names and numbers for this year's composition competition as follows: There were 19 contestants in all, representing 7 teachers:
3 Elementary
8 Junior
4 Senior
4 Young Artist
3 judges: Charlotte Bray, Mark Kross, and Tish Kilgore.

## 4. MMTA Student Awards Grant Proposal

Alison presented the new grant guidelines which were developed as a result of Vera's observations at the June 2016 meeting. It was agreed that Vivian would receive applications on line and that the board would vote on grants via email.

Discussion was held regarding the dollar amounts that would be granted to each student, resulting in a change in the proposal to read: Under "Grant Amount and Frequency" "The amount of each Student Grant will be determined on a case by case basis. Students may apply for this grant in consecutive years." Heather remarked that the application should make it clear that all expected expenses should be stated on the applications.

Motion by Valerie, Second by Vivian: Accept the Student Grant Application as presented with the adjustments noted above. Vote: Motion Passed unanimously.

Motion by Dorothy, Second by Valerie: A new line item for "student grants" will be added to the MMTA FYE 6/30/2017 annual budget in the amount of $\$ 4,000$. Vote: Motion Passed unanimously.

## 5. Job Descriptions

Dorothy and Vivian reported that current job descriptions are now located at massachusettsmusicteachers@gmail.com, password Music\$123. Dorothy requested that officers review their job descriptions and be prepared to update them as necessary. It was agreed that in the future, all such documents will be stored in google documents, and that folders should be created for subcategories such as financials, events, and so forth.

## 6. Judged Festival Report

Heather opened her presentation with a call for accolades to Vivian for her success with the creation and development of the judged festival. The following is her report on the current status of this years' festival:

- Judged Festival is Saturday March 4, 2017 @ Gordon College
- Theme: Romantic
- Non-member fee is $\$ 70$ (reduced from $\$ 100$ last year.) Must join MMTA by Jan. 15 to avoid fee.
- Registration for event will be open $12 / 1 / 16$ to $2 / 1 / 17$.
- Judged Festival details are up on mmta.net now, including Repertoire List \& Rules. Find it under: Student Programs > Judged Festival or use this link: Judged Festival

The budget for the event is the same as the previous year and includes a $\$ 1,500$ fee to Gordon College.

## 7. Website Report

Vivian was also asked and agreed to find a more obvious and distinct placement for our existing Student Scholarships on the website.

Dorothy inquired about the previously discussed idea to redesign the MMTA website. Those present agreed that this is not a priority at this time.

She expressed the opinion that unless college programs foster and promote the value of national certification among young teachers, the number of members seeking this status will remain low. It was also requested that issues regarding certification be added to the agenda for our next meeting.
