(2) Treasurer's Report (Yulia - 5 min) see attached

Thank you to Ellyses for launching the campaign to support the Music Connect program honoring Alison Barr.

Alison Barr acknowledged the challenges Yulia regularly takes on as treasurer and commended her for how she handles them efficiently and thoroughly.

(3) Membership Report (Yulia - 5 min) 211 members, which is consistent with the past year.

Ellyses pointed out the report says 2011, and will be corrected to 211.

A question was asked about non-member teachers registering students for events, and it was noted that teachers entering students in the Bay StateStrings or Piano competitions must have membership application completed by Jan. 31 of the year.

Reports of Officers

Application and Toy 2022 (Jonathan - 15 min) (report attached)
 The deadline for member applications for enrichment fund assistance to pay for

attending the convention is extended to Feb. 15. The deadline for registering for the conference itself is also extended, as it has changed to 100% virtual only recently. Ellyses mentioned this would be a good time for collegiate students and members to attend. The deadline for collegiate members is to register for the conference is March 3, and student membership costs are affordable.

Dorothy remarks that this is the first time we have had an Applications Chair office on the board (a role for the President-Elect), to help keep these benefits known to the

There are two nominees for Teacher of the Year. See attached. Alison read the definition of the teacher of the year qualifications, which included service to MMTA. A vote was taken, and Yulia zhuravleva Potvin was chosen unanimously.

Vera mentioned that there seems to be a need to recognize teachers who are non-officers, but who are serving the profession, as this other candidate has been, and many other teachers are doing, who deserve recognition.

(Action) ***Alison volunteered to look into how other states are doing something similar, and make a proposal for the next meeting.

When does the announcement of TOY happen? Once the announcement is posted on the website, with photo, a blast will be sent out to the membership

- MAE Event Jia Shi (report attached) Will be March 6, Sharon Music Academy How much to pay judges? There is a set of guidelines that chairs should have. 2016 judge stipend policy exists. Dorothy shared the document. (see attached in drive) Some discussion ensued.
- 3. Judged Festival (Ranko 5 min) (report attached) Engaging judges remotely on a weekend is still a challenge because there is a need for synchronization. The discussion of judge payment continued. Dorothy proposed the hourly price range be raised to \$45-65 per hour, with flexibility left to the chair's discretion. Alison seconded, and vote passed unanimously. The document has been updated.
- 4. Bay State Strings (Vera 5 min) (report attached) Date is not yet established. There are many questions about venue, pandemic-related issues regarding judges' availability, etc. The date may be announced by the end of February, but registration deadline will be May 8, and opening date for registration will be announced with the event date announcement.
- 5. Bay State Piano (Esther 5 min) (report attached) Esther is still hoping for a live competition at Boston Conservatory. She will know within a week. Tentative date May 21. May be virtual. There was some discussion about the location. It was at one time held at Fitchburg State University. The comment was made by teachers about how difficult it is to record. Alison mentioned how reluctant universities are to commit to hosting outside groups this year.
- 6. MTNA Performance Competition (Jonathan 5 min) One of the winners of our state contest is the alternate for the National Competition on the piano.
- 7. 2022 MTNA Conference (Ellyses 5 min) completely virtual. MTNA will also make so much of the conference available for viewing after the fact.
- 8. Nominating Committee (Dorothy 5 min) (report attached) Ellyses is current Interim President and will be Immediate past president. If Heather can, she will return as Immediate Past President.

The slate was presented as it is in the report in the Drive.. Appreciation was expressed

for new nominees.

- 9. Music Connect Program (Alison 5 min) (report attached) \$3400 has been raised in honor of Alison's nomination for the program, Ellyses pointed out. Esther asked the question about a possible scholarship for instruments for students which led to a discussion about possibly putting a place on the website for information sharing about pianos and other instruments available and/or sought.
- 10. Composer's Commission. (report attached) Dorothy shared that Maine MTA is so proud and happy that their commissioned composer is the national winner of the Commissioned Composers, and will be featured at the national convention.
 - She is looking for volunteers to help review applications for the next commissioned composer.
- 11. Webmaster and Archivist (Ellyses 5min) (report attached) Elllyses thanks us for giving lead time to get information posted.
- 12. Communications Chair (Rebecca 5min) (report attached) Rebecca also expressed appreciation for lead time and clear concise information for her communications. Future deadlines are in the attached report, especially note the summer newsletter. Sending all dates and information all in one doc is a good idea and helpful. She can use fonts and colors and make things look nice. Appreciation was expressed for both Ellyses' and Rebecca's helpful work.
- 13. New / Unfinished Business (TBD)

Ellyses reminded the board to cast votes for the Eastern Division offices.

The TOY celebration, as well as the celebration of Alison's national honor is hoped to be outside. Location, Vera Rubin's, date: Saturday, June 25.

The need for acknowledging teachers in our organization, beyond the TOY, is again expressed. Also a need for guideline, criteria, and a calendar of nominations needs to be established. Alison volunteered to write the document as soon as possible, to possibly implement the honor this year. Alison noted that nominations will need to be made that include the criteria. *****(need for action has been previously noted, just now there is a request to work on this in the immediate future for board feedback.)

Esther Ning Yau mentioned she has noticed the need for including an ensemble competition, i.e. chamber groups. The precedent for this happened in the past, with a big push, and there was a small response at the time. Esther wonders if it might be worth the time to build it up. There needs to be resources to build it up. Jia, Yulia, and Vera expressed interest in helping to initiate a program like this.

David Ibbett joined the meeting briefly and was introduced. He is the composer of our commissioned piece for the 2021 Quad State event. He has also volunteered to be the next treasurer, beginning in June 2022..

To whom it may concern,

I am writing to nominate my dear colleague, Mina Osako, as Music Teacher of the Year for 2022. Mina has been a member of the MMTA since 2016, and we first met at the Yamaha Music School of Boston in 2015. At that time, I had just moved from the UK to the USA and had so much to learn about the new culture of music making. Mina - the School's Curriculum Coordinator - took the time to make me feel at home and valued in the new setting, while encouraging me to teach in my own way and develop my own personal approach. It is largely because of her that I thrived at the school and together we co-caught many students on the Junior Original Composition program. I would assist them in composing new pieces, and Mina would help them to figure out how to play what they'd written - a huge challenge every time! I would often be convinced that we'd been too ambitious with a particular piece, and then - somehow, with great hard work - Mina and the student would figure out a way to make the imaginative new sounds playable. It was always a joy to see the students performing their own personal compositions with such pride and confidence, thanks to Mina's incredible efforts.

In August 2021, the Yamaha School suddenly shut down - to the dismay of the students and teachers. Over the following weeks, Mina worked tirelessly to create a new school in order to provide continuing education for the kids and parents who had the rug pulled out from under them. Because of her hard work and passion, the wonderful Yamaha YMES curriculum continues to thrive in Boston - and an entire community of musicians at her private studio and the Real School have Mina to thank.

Mina's music teaching philosophy is "music is singing, and singing is music.", with an emphasis on listening to yourself and to others. Her passion for singing began when she was young with her

own education in singing and ensemble playing. Because of this unique background, Mina works to give her piano students the opportunity to play in keyboard ensembles - a truly special and invaluable experience that most pianists do not receive, preparing them very effectively for a wide variety of musical ensembles in the future.

It gives me great pleasure to nominate Yulia Zhuravleva Potvin for the award of MMTA Teacher of the Year 2022.

Yulia Zhuravleva Potvin joined MMTA in 2013. Though her tenure with the organization has been relatively short, she has jumped into service to the organization in some of its most demanding roles. She's done this with little or no time for adjustment or preparation. She has worked quietly and with deep perseverance, giving unstintingly of her time and dedication. I have never heard Yulia say anything but "YES" when asked to produce a new report, answer a question, present something in a different format or communicate with National to sort out a problem or concern. She explains things to the Board carefully, with a soft-spoken and patient demeanor. Her time has become MMTA's time, without reservation. And all this while she maintains an active professional life as a concert violinist, freelance performer and teacher of violin at her independent studio in Westborough, MA; Adjunct Faculty at Worcester Polytechnic Institute and Violin Instructor for Shrewsbury Public Schools Instrumental Lessons Program.

Yulia has served as MMTA's Vice President of Membership since 2016. In 2018, she stepped into the very difficult position of Treasurer. This position is a demanding one because its work requires extreme precision, quick response time and to-the-penny accuracy. Also, the technology surrounding filing reports and interacting with the MTNA National Office changes rapidly. Yulia willingly kept her position as Vice President of Membership. She now serves in both capacities concurrently. This is extraordinary because we ask so many members to take on one office or another and we get so many "No, I'm too busy" responses. Yulia Zhuravleva Potvin, however, has the opposite attitude, making ample space in her life for this service.

I've had the great good fortune to work closely with Yulia as I navigate the financial aspects of MMTA's Music Connect Program. She responds to the needs of this program with speed, respect, thoughtfulness and a cheerful, humorous attitude which always makes me feel less harried and more reassured. Yulia is a joy to work with!

Please read Yulia's professional bio. (I am certain there are accomplishments that are missing from this bio.) Yulia is obviously an extremely gifted musician, completely devoted to the field of music teaching. Her students surely experience the same joy and excitement that she does. Yulia's professional service is a natural extension of her teaching and performing.

Ms. Yulia Zhuravleva is a representative of the Russian style of teaching and playing the violin. Her professional studies of music began at the age of six at the Special Music Lyceum for Gifted Children in Ekaterinburg, Russia. She received double degrees in both violin performance and art management, and then she went on to complete her post-graduate studies at the St. Petersburg

Conservatory. In 2009, she moved to the United States and became a Graduate Assistant at Ball State University in Indiana.

Yulia has always been drawn to teaching. Many of her students have continued their professional music studies at major Russian music schools in Moscow and St. Petersburg. At the age of twenty-five she obtained a violin instructor position at the St. Petersburg Conservatory and held it for almost two years until she was invited to pursue an Artist Diploma in the United States.

She regularly performs as a soloist, member of chamber ensembles, and in professional chamber and symphony orchestras. Yulia's musicianship has been internationally recognized by receiving awards from the All-Russian Chamber Ensemble Competition (Russia; First prize), a Maria Yudina International Competition (Russia; Diploma), International Competition in Jyväskylä (Finland; Second Prize), and Matinee Musicale (USA; Second Prize). She has performed at summer festivals such as the Eastern Music Festival (Greensboro, NC), the National Music Festival (Floyd, VA), Chamber Music Seminar (Pittsburg, PA), and the Modern Early Music Institute (Washington, DC).

Yulia Zhuravleva Potvin embodies the spirit of the MMTA Teacher of the Year award. She is an MMTA member of whom we can be proud -- generous, intelligent, and open. No task is too difficult or too time-consuming for her. Yulia, we thank you for your professional service thus far and hope that MMTA can give back to you in equal measure what you have given.

Pleased to announce that the Maine Commissioned Composer, Delvyn Case, whose work entitled "*Psalms of Ascent*", was chosen as the MTNA Commissioned Composer.

Our Massachusetts Composer, David Ibbett, is in the process of completing his *Black Hole Symphony* , for which he had a successful kickstarter campaign.

David has agreed to be on the June ballot for MMTA Board Treasurer for 2022-2024. He will try to join us for the next two Board meetings to come up to speed on the workings of our treasurer.

The selection committee for the next Commissioned Composer will review submissions in November of 2022. Three members-Jonathan (as MMTA President), Dorothy Travis as Commissioned Composer Chair and one other MMTA member.

- **December 1, 2023** Deadline for MMTA Commissioned Composer Chair to submit the commissioned composition to the MTNA Distinguished Composer of the Year Award Competition.
- **March 2024** Performance of the composition from the MTNA Distinguished Composer of the Year at the MTNA National Conference Minneapolis, Minnesota.

MMTA Judge Stipend Policy Proposed and approved at June 2016 Board Meeting Updated at February 2022 Board Meeting

- 1. All judges will be offered a stipend and not at an hourly wage.
- 2. Judges may receive a mileage allowance of 57 cents per mile for a round trip **or whatever rate is set by the IRS (based on Google distances)**. This mileage allowance is capped at \$50 without MMTA Board approval.
- 3. Chairs may offer a meal allowance of up to \$15 per judge if lunch is not provided at the venue.
- 4. Chairs may offer a parking allowance not to exceed \$25 per judge as needed.
- 5. Judges not traveling by car are allowed a travel allowance of up to \$25 as needed.
- 6. The stipend is determined by the chair and based on an hourly wage of between \$45 and \$65 per hour. The Chair has discretion to set the hourly wage using historical precedent, budget, or incentive as a rational.
- 7. All judges working together on the same competition should receive the same stipend for the same amount of time on the same day.

Example: Judge needed from 8 to 5 (9 hours) Stipend would be between \$405 and \$585 at the discretion of the chair.
